On behalf of the applicant, Green Ridge Recycling and Disposal Facility, LLC ("County Waste" or Company"), we are requesting an extension to respond to the Additional Information Request Letter dated May 13, 2022 from the Virginia Department of Environmental Quality (VDEQ); this letter requested a response by July 12, 2022. We have been working to provide additional information and data that the VDEQ has requested; however, several requests are related to the surface water impact quantities and mitigation credits, the final data for which will not be available by the requested response date, as discussed below.

An updated Preliminary Jurisdictional Determination (PJD) was requested from the US Army Corps of Engineers (USACE) on June 3, 2022. The USACE has requested revisions to the PJD mapping of jurisdictional areas located within the project limits. The surface water impact quantities and mitigation credits may be revised during the update of the PJD; thus, the PJD work needs to be completed to submit an accurate comment response.

We, therefore, ask that the deadline to respond to the referenced letter be extended to the Fall of 2022. This extension will allow for a thorough response once the approved PJD is received.


