Dear Mr. Jones,

On behalf of the applicant, Green Ridge Recycling and Disposal Facility, LLC ("County Waste" or Company"), we are requesting an extension to respond to the Additional Information Request Letter dated May 13, 2022 from the Virginia Department of Environmental Quality (VDEQ); this letter requested a response by July 12, 2022. We have been working to provide additional information and data that the VDEQ has requested; however, several requests are related to the surface water impact quantities and mitigation credits, the final data for which will not be available by the requested response date, as discussed below.

A Preliminary Jurisdictional Determination (PJD) was requested from the US Army Corps of Engineers (USACE) on September 29, 2022. The surface water impact quantities and mitigation credits may be revised; thus, the PJD approval is desired prior to submitting a comment response.

We, therefore, ask that the deadline to respond to the referenced letter be extended to May 31, 2023. This extension will allow for a thorough response once the approved PJD is received.
