## **Crosswalk of Regulations (Current v. Previous Chapter)**

This document provides a crosswalk of Amendment 3 to the <u>Virginia Regulated Medical Waste Management</u> <u>Regulations (9VAC20-121)</u>, to clarify the new location of each part and section in the current chapter (Chapter 121) compared to the previous chapter (Chapter 120).
