OSRR Regulatory Activity

- **Periodic Reviews**
- **Changes to VPDES General Permit**
 - Changes to water quality standards
 - Broader scope of discharges considered under permit
- **Effective Date March 1, 2023**

OSRR Regulatory Activity

- **Periodic Reviews 2023**
 - Facility and Aboveground Storage Tanks
 - Tank Vessel *ODCP* and Financial Responsibility
 - UST Technical Standards and Corrective Action
 - Petroleum UST Financial Responsibility
- **No changes to regulation expected**
- **ODCP: Oil Discharge Contingency Plan**

New VPDES General Permit



- Groundwater Remediation of Contaminated Sites, Dewatering Activities of Contaminated Sites, and Hydrostatic Tests
 - Previously specific to **petroleum** contamination
 - New language for dewatering
- Effective Date **March 1, 2023**

- Release Reporting and Cleanup

Non-Regulated Tanks

- Heating oil tanks for on-site consumption
- Process and equipment tanks
 - Transformer and insulating oil
 - Hydraulic lift tanks
- Emergency overfill tanks

Release reporting is still a requirement

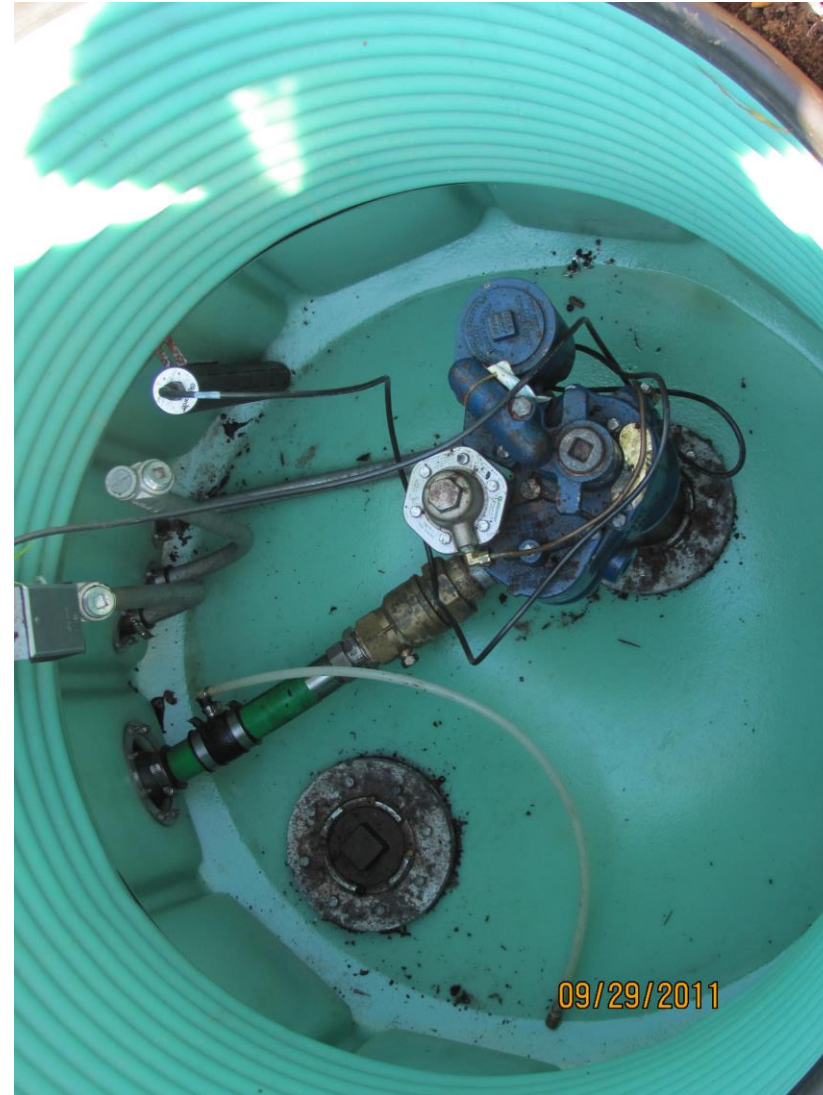
