Re: Assignment of Percent Removal Efficiencies for Total Phosphorus

StormKleener™ Cartridge System (StormKleener Filter)

Dear Ms. Buck:

The Department of Environmental Quality (Department or DEQ) received the Proprietary Best Management Practice (BMP) Registration Statement and supporting documentation for the **StormKleener™ Cartridge System (StormKleener Filter)** on June 11, 2018. The Department has reviewed the application and supporting documentation in accordance with § 62.1-44.15:28 of the Code of Virginia, 9VAC25-870-65 D of the Virginia Stormwater Management Program (VSMP) Regulation, and DEQ Guidance Memo No. 21-2006.

Section 65 D 2 of the VSMP Regulation states, "Any proprietary BMP approved for use after July 1, 2020, must meet the requirements of § 62.1-44.15:28 A 9 of the Code of Virginia." The Department received the current general use level designation (GULD) certificate from Washington State's Technology Assessment Protocol – Ecology (TAPE) program or the current certification from the New Jersey Department of Environmental Protection (NJDEP) for the **StormKleener<sup>TM</sup> Cartridge System (StormKleener Filter)**.

The <u>StormKleener™ Cartridge System (StormKleener Filter)</u> is approved for use in Virginia to meet the VSMP water quality design criteria requirements and has been assigned a total phosphorus pollutant removal efficiency of <u>40%</u>. This information will be posted on the Virginia Stormwater BMP Clearinghouse website. This device and the assigned removal efficiency can be manually added into the Virginia Runoff Reduction Method spreadsheet to demonstrate compliance with VSMP water quality design criteria requirements.
