Consent Decree: (*Release of Sediment off ROW into Surface Waters*)

- STA 14916+00: Stream S-G16, "Strawfield Creek" (Bore Crossing). Approach for bell hole inside the 50' buffer was shot causing the stream bank to slump into the stream. This caused impacts to surface waters less than 300 LF of stream. Impact occurred on 10/17/2023 and was remediated the same day.
