PURPOSE OF NOTICE: To seek public comment and announce a public hearing on a draft permit from the Department of Environmental Quality regarding coal combustion residuals (CCR) surface impoundments at the Chesterfield Power Station in Chesterfield County, Virginia.

PERMIT APPLICANT: Virginia Electric and Power Company (d/b/a Dominion Energy Virginia) 120 Tredegar Street, Richmond, Virginia 23219.

FACILITY NAME AND LOCATION: The facility is located at 500 Coxendale Road in North Chesterfield County, Virginia. The surface impoundments are located to the southeast of the Chesterfield Power Station and bordered to the north by Coxendale Road and to the east by Henricus Park Road, to the south by Dutch Gap Conservation Area, and to the west by the James River.

PROJECT DESCRIPTION: This proposed solid waste permit is to address closure of the coal combustion residual (CCR) surface impoundments at the Chesterfield Power Station in North Chesterfield County, Virginia. The proposed closure by removal of surface impoundments Lower and Upper Ash Ponds are addressed. This proposed permit also includes EPA CCR Rule requirements as well as groundwater monitoring and surface water monitoring at the facility for both CCR surface impoundments.
