

HAZARDOUS WASTE PERMIT MODIFICATION APPROVALS 07/01/24 - 06/30/25

Overview

Under the Virginia Hazardous Waste Management Regulations (VHWMR), the Department of Environmental Quality (DEQ) must maintain a list of approved hazardous waste management permit modifications. This list must be updated annually. In addition, a notice must be published in a statewide newspaper that an updated list is available for public review. Table 1 below provides information regarding the permit modification approvals that were issued during the most recent state fiscal year ending on June 30, 2025.

Table 1 - This table provides information about hazardous waste permit modifications approved by DEQ between July 1, 2024 and June 30, 2025. It includes the following information: facility name and location, EPA identification number, the classification of the permit modification, a summary of the modification and the date of approval. Permit Modification Classifications are defined in 40 CFR § 270.42.
