

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that Transcontinental Gas Pipe Line Company LLC, a Delaware limited liability company, having its principal place of business in the City of Houston, County of Harris, State of Texas, hereinafter sometimes referred to as the "Company," does hereby make, constitute and appoint JOSEPH DEAN its true and lawful Attorney-in-Fact, giving and granting onto him full power and authority to the extent permitted by law or regulation to execute and deliver for and on its behalf for its sole and exclusive benefit and not on behalf of any other person or entity, in whole or in part, the following described instruments and documents with the United States Environmental Protection Agency (USEPA), the United States Army Corps of Engineers (USACE), the United States Fish and Wildlife Service (USFWS), the National Marine Fisheries Service (NMFS), Bureau of Safety and Environmental Enforcement (BSEE), the State of Texas Historical Commission, the State of Texas Commission of Environmental Quality (TCEQ), the State of Texas Parks and Wildlife Department, the State of South Texas, Office of State Engineer, the Railroad Commission of Texas, the State of Louisiana, Historic Preservation Office, the State of Louisiana, Department of Natural Resources (LDNR), the State of Louisiana, Department of Environmental Quality (LDEQ), Louisiana Office of Cultural Development (LOCD), the State of Louisiana, State Engineer's Office, the State of Louisiana, Department of Wildlife and Fisheries (LDWF), the State of South Carolina, Department of Archives & History, State Historic Preservation Office (SC SHPO), the State of South Carolina, Department of Health and Environmental Control (SC DHEC), the State of South Carolina, Department of Natural Resources (SC DNR), the State of South Carolina, Office of State Engineer, the State of Georgia, Environmental Protection Division (EPD), the State of Georgia, Department of Community Affairs, Historic Preservation Division, the State of Georgia, Department of Natural Resources (GDNR), the State of Alabama, Department of Environmental Management (ADEM), the State of Alabama, Alabama Historical Commission (AHC), the State of Alabama, State Engineer's Office, the State of Alabama, Department of Conservation and Natural Resources (ADCNR), the State of Mississippi, Department of Environmental Quality (MDEQ), the State of Mississippi, Department of Archives & History (MDAH), the State of Mississippi, State Engineer's Office, the State of Mississippi, Department of Wildlife, Fisheries, and Parks, the State of Mississippi, Department of Marine Resources (MDMR), the State of North Carolina, State Historic Preservation Office (NC SHPO), the State of North Carolina, Department of Environmental Quality (NCDEQ), North Carolina Wildlife Resources Commission, the State of North Carolina, State Engineer's Office, the State of Virginia Department of Environmental Quality (VDEQ), the State of Virginia, Department of Historic Resources (VDHR), the State of Virginia, State Engineer's Office, the State of Virginia, Department of Wildlife Resources (VDWR), the State of Virginia, Virginia Department of Conservation and Recreation (VDCR), the State of Virginia, Virginia Marine Resources Commission (VMRC), the State of Maryland, State Historical Trust (MHT), the State of Maryland, Department of the Environment (MDE), the State of Maryland, Department of Natural Resources (MDNR), the State of Maryland, State Engineer, and with agencies, counties, townships or other political subdivisions of the States of Texas,

Louisiana, Mississippi, Alabama, Georgia, Florida, South Carolina, North Carolina, Virginia, and Maryland, and with tribal authorities.

1. Permits and related documentation pertaining to compliance with the Clean Water Act or state equivalent, including without limitation, water quality certification, dredge and fill, discharge to water resources, or temporary withdrawal or appropriation of water resources, construction stormwater management, and impact to or crossing of water resources.
2. Permits and related documentation pertaining to compliance with the National Environmental Policy Act or the State Environmental Policy Act, including without limitation Environmental Assessments, Environmental Impact Statements, and documentations relating to Categorical Exclusion.
3. Permits and related documentation pertaining to historic preservation and cultural resources with USACE and/or potentially affected states or tribes with state or tribal historic preservation authorities.
4. Permits and related documentation pertaining to wildlife and endangered species, including without limitation documentation relating to compliance with the Endangered Species Act or the Migratory Bird Treaty Act.
5. Permits and related documentation pertaining to waste management, including without limitation documentation relating to spill prevention and response, groundwater protection, and storage, transportation, disposal of waste, including hazardous and non-hazardous waste, residual waste, and E&P exempt waste.
6. Environmental documentation related to or in support of filings at the Federal Energy Regulatory Commission, including without limitation affirmative statements, environmental information and data responses, prior notice reports, supplemental filings, implementation plans, and construction status reports.

The authority conferred by this Power of Attorney shall extend to such other acts of any nature and kind required or desirable in carrying out or incident to carrying out the purposes of the Power and such terms, conditions and reservations as the Agent and Attorney-in-Fact may deem expedient or appropriate, hereby granting to him the power and authority to do and perform any and all acts and things whatsoever necessary or proper to be done in carrying out the foregoing.

The power and authority hereby conferred upon JOSEPH DEAN shall be effective as of the date hereof and shall continue in full force and effect until the earlier of (i) the date this Power of Attorney is expressly and duly revoked by the Company, or (ii) one (1) year from the date hereof.
